



Online Services

On August 8, 2005, online licensure verification became a reality. If you haven't looked at your licensure information, please take a moment to do it! It's as easy as 1-2-3!

Go to our website at www.dpr.delaware.gov

1. Click on Nursing.
2. Now click "Verify License Online" (at the bottom of the left menu).
3. Enter your license number (If you put in your name only, click on your name from the list that appears.)

The individual page information includes your name, license number, original and expiration dates, city and state of residence and disciplinary data, if applicable.

ADDRESS CHANGES

You can also now change your address online by clicking the Change Contact Information link. No more need to worry about did

you mail or fax an address change and did the Board office receive it. You can now visit our website and make the necessary changes!

Name changes cannot be done online, because the legal document needs to be on file at the Board office to process a name change.

RENEWALS

LPN's—get ready to renew your February 2006 licenses ONLINE! It's quick, user-friendly and you can print out a receipt of your transactions. For those nurses who are not being audited for continuing education or practice requirements, don't have name changes or whose answers do not result in submission of documentation, your license will be printed and mailed the next business day.

During the first week of December, postcards will be mailed to all Delaware licensed LPN's advising

that licenses can be renewed online. If you prefer a paper renewal, you will be apprised of how to request one on the postcard. We hope that the majority of LPN's will renew online, but if you prefer not to, it's okay.

CORE

The Delaware Board of Nursing asks your assistance as it participates in the Commitment to Regulatory Excellence program (CORE). National Council State Boards of Nursing, Inc. developed CORE as tool for nursing boards to evaluate areas of licensure, practice, education, discipline and governance. Questionnaires are sent to licensees, employers, nursing organizations and complainants to collect feed-back about services rendered by the board.

CORE was developed in the 1990's and thus is in the 2nd and 3rd generation of survey tools and identification of best board practices.

The use of CORE serves two purposes. It provides a report card of board services, identifying strengths and opportunities for improvement. A board can also measure itself against the best practices and set it's objective accordingly.

Board members and staff are excited about participating and ask that if you receive a questionnaire, you complete it.

Online Renewal Process

What you will need:

1. Current contact information
2. Continuing Education information
3. Computer connected to a printer
4. Social Security Number
5. Email address
6. Credit card

To Renew Online

- When you receive your postcard, go online at www.dpr.delaware.gov

(If you are selected for audit, you will receive a separate mailing.)

- Register for online services

(To register you will need your SSN and

email address.)

Note: LPN's who do not have a SSN will receive a Registration ID in the mail.

- Choose renewal
- Read and follow instructions on each page
- Print out Summary page.*

* If the instructions require you to send in documentation, you must print the Summary page and enclose it with your documents.

- Enter credit card information
- Print out payment confirmation for your records.

What happens next

If your renewal is complete and no documentation is required, your renewed license will be printed on the next business day. If documentation is required, your license will not be renewed until the Board office receives and approves the required documents, including any audit information.

- Please allow sufficient mail delivery time to receive the license.
- You may confirm the renewed license by visiting our website at www.dpr.delaware.gov.

Statewide Calendar System

The Delaware Statewide Calendar System (DESC) was established in July of 2004 to provide a centralized location for citizens to receive notification of public meetings and events. After a year of successful operation, the DESC was approved by the Secretary of State as the official system mandated by Senate Bill 131 for electronic posting of meetings, meeting agendas and minutes.

Currently all Delaware Board of Nursing meetings and hearings are posted online. After January 1, 2006, agendas and minutes of all meetings and hearings will be available as well.
